INTB 2000: Introduction to International Business
ASIA 3386: Asian Century: Modern Korea
The program offers up to 6 university transfer credits.

Instructors Kenneth Wong and Avram Agov will lead students through an eye-opening 21-day itinerary, visiting Hong Kong, Shenzhen, Seoul, and Busan. This field studies tour will be packed full of experiential learning gained by visiting local businesses, universities, and numerous historical and cultural sites.

Students will visit and attend lectures at top ranking campuses at the University of Hong Kong, Shenzhen Polytechnic, Yonsei University, and Seoul National University and will capture a glimpse of university life.

Students will have ample free time to explore each city on their own. Most weekends and evenings will be kept free for your personal adventure. **Hong Kong** is a major financial centre of Asia, bringing together the old and new in the once colonized city of 7 million people. Experience the bustling pace of city life and be rewarded with a wide variety of cuisine at the end of the day.

Shenzhen, a Special Economic Zone,is home to tech giants like Tencent and Huawei and showcases the modernization that has occurred during the last 25 years as the city as grown from a village to a mega metropolitan city.

Seoul, a two-millennia-old economy, is home to over 20 million people and is the symbol of one of the Asian Tigers. Students will tour cultural areas like Insadong to become familiar with the culture, history, and traditions, and visit Gangnam where they will explore modern eateries and popular Korean cosmetics. Trips to the open markets and the business centres of Suwon and Yongin - where Samsung Electronics plant and other businesses are located - will provide invaluable first-hand experience of South Korean business.

Busan is the second largest city and a gateway to South Korea, boasting the 9th busiest sea port in the world. Busan and its surrounding area is the location of 40% of South Korea's industry, including corporate powerhouses like Hyundai Motors and Pohang Steel.

PROGRAM

This program is open to those who meet Langara College's admission requirements. We also welcome students from other post-secondary institutions as well as members of the general public who are interested in interdisciplinary studies of Korean and Chinese business and historical culture. All applicants will go through an informal interview with the tour leaders prior to being accepted into the program.

Through lectures and visits to businesses and cultural sites, students will have an opportunity to:

- Witness first-hand the business activities and cultural/ historical sites on field trips
- · Actively engage in discussions with businesspeople
- Directly participate in cultural activities

What is included in the program fee

- Accommodations: Shared rooms in all the cities
- Most group meals
- Group transportation: train ride between Seoul and Busan; bus transfers between airports and accommodation; visits to cultural sites and businesses
- Admissions: Entrance fees to attractions

What is not included in the Program Fee

- Airfare, international, and any domestic (including airport taxes)
- Tuition and registration fees for Langara College, textbooks, and course materials
- Gratuities for local tour guide and tour bus driver

COURSES

INTB 2000: (3 credits) Introduction to International Business

Focus is on the role of international trade, the international business environment and Canada's dependence on, and role in, international business. Gain an understanding of international business, globalization, and the importance of international business to the Canadian economy. Students are also introduced to alternative methods of conducting business internationally and reasons for and different types of government and private sources of assistance to international business. (For the purpose of this field study program, the focus will largely be on Korea and China).

ASIA 3386: (3 credits) Asian Century: Modern Korea

This interdisciplinary study of modern Korean society addresses the economic, social, and cultural transformation of modern and contemporary Korea. Students study the development of the South Korean "economic miracle," the factors shaping its political economy and its integration into the global economy.

Alternative courses are available for those who have already taken either course.
